6.7 Sask Polytech's Tuition & Fees Policy

6.7.1 Refund Period - Tuition & Fees Policy

Dallas discussed the following Tuition & Fee Policy concerns with AVP Strohan:

- Refunds definitions are unclear.
- Withdrawal dates tight timeline.
- Requested rationale for tuition fee increases.
- The entire Policy needs more clarity.

AVP Strohan indicated that this Policy will undergo an extensive consultation process this academic year. AVP Strohan has indicated that a student has been hired to research other institutions' tuition policies. The SPSA Student Affairs Committee will review the present Policy and develop recommendations.

Again, noted was the fact the Sask Polytech decision makers do not hear concerns/suggestions directly from student representatives but rather suggestions may or may not be disseminated through a Sask Polytech employee. If the decision makers do not hear directly from student representatives how do we know whether or not our suggestions/concerns will be addressed or even heard.

6.7.2 Research Other Institutions' Tuition & Fees Policy

Justin provided background on the approval process relating to the amendments of Policy 506G Policy Development and Administration and Policy 1214 Tuition & Fees. At the time of these amendments, decision makers did not hear directly from the student voice as there was no student representative named to the Board of Directors at that time. Members discussed concerns with how the student voice will be provided



to decision makers now that the authority to amend has been eliminated from the Board of Directors' level.

Tara will distribute additional information on the recent changes to Saskatchewan Polytechnic's Policy development procedures. Tara will join the Executive Council Meeting on November 7, 2018 to provide additional background information.

- On some days there were too many events going on, therefore, students were required to make a choice as to the event they would attend.
- There was some indication that the events were juvenile in nature and not college type events.



Will provided a review of the presentations by Moose Jaw Business students regarding this year's Welcome Week. Key takeaways:

- It really is only one day of events as students can not get out of classes
- marketing fell short, utilize other avenues ie) advertise on bright space and acceptance letter
- Instructors have no ideas what is going on and they should be provide accurate information on upcoming events.
- Exhibitor's hall was not well received
- Will noted that a video of the presentation will be made available for viewing, of which Sask Polytech will be offered a copy.
